



eSentio Sponsored Events Privacy Policy

1. Introduction

eSentio Technologies ("we," "us," or "our") is committed to protecting the privacy of the participants ("you" or "participants") attending our sponsored events (the "Event(s)"). This Privacy Policy outlines how we collect, use, disclose, and protect your personal information in connection with Events.

2. Information We Collect

We may collect the following types of personal information:

- **Registration Information:**
 - Name
 - Job title
 - Law firm/Company
 - Email address
 - Phone number
 - Dietary restrictions
 - Accessibility requirements
- **Payment Information:** (If applicable)
 - Credit card details (processed through a secure third-party payment processor)
 - Billing address
- **Event Participation Information:**
 - Attendance records
 - Feedback and survey responses
 - Photographs and video recordings (with your consent, as applicable)
 - Information shared during networking sessions or workshops (if you voluntarily share it)
- **Technical Information:**
 - IP address
 - Browser type
 - Device information
 - Website usage data (if applicable, for event website or registration portals)

3. How We Use Your Information

We use your personal information for the following purposes:

- To process your event registration and payment.

- To communicate with you about Events, including updates, schedules, and logistical information.
- To provide you with event materials and resources.
- To accommodate your dietary restrictions and accessibility requirements.
- To improve the Event and our services.
- To conduct surveys and gather feedback.
- To take photographs and videos for promotional and archival purposes (with your consent).
- To facilitate networking among participants.
- To comply with legal obligations.
- To ensure the safety of the event.

4. Sharing Your Information

We may share your personal information with:

- **Event Vendors:** Third-party vendors who provide services related to the Event, such as venue providers, catering services, and technology providers. These vendors are contractually obligated to protect your information.
- **Event Sponsors:** With your consent, we may provide a participant list.
- **Other Attendees:** With your consent, we may provide a participant list to enable networking.
- **Legal Authorities:** If required by law, we may disclose your information to comply with legal obligations or to protect our rights.
- **Payment processors:** If payment is taken, that information is shared with those processors.

5. Data Security

We implement reasonable security measures to protect your personal information from unauthorized access, use, or disclosure. These measures include:

- Secure data storage.
- Encryption of sensitive data.
- Restricted access to personal information.
- Using secure third-party platforms.

6. Data Retention

We will retain your personal information for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law. For example, financial records may be kept for legal reasons.

7. Your Rights

You have the following rights regarding your personal information:

- **Access:** You can request access to the personal information we hold about you.
- **Correction:** You can request that we correct any inaccurate or incomplete information.

- **Deletion:** You can request that we delete your personal information, subject to legal limitations.
- **Objection:** You can object to the processing of your personal information.
- **Withdrawal of Consent:** If we rely on your consent to process your information, you can withdraw your consent at any time.
- **Data Portability:** You can request a copy of your data in a machine readable format.
